The first year I was in the Senate, it took 30 minutes to take care of business, but this year the meeting was two and one-half hours long with a lot of discussion and heated comments. However, we all came out speaking (to each other). Some of the highlights of the Senate meeting were:

- Wording of the mission statement was changed somewhat. However, it is posted on the website for public/member comments before it is actually voted on as official. Please go to www.AAFCS.org and make comments if you have any.
- The P/GS will now be called the Student Unit.
- Retired members who pay retiree dues will no longer automatically receive the FCS Journal unless they opt to pay extra for it (proposed was a dues increase for retirees, but it will remain the same with the journal not being part of the package). These members will be called Emeriti members.
- The board structure will change somewhat to provide more continuity as members go off and on. There will be no more sections and divisions, but "communities of interest" instead. Some of the sections/divisions will just change to communities of interest, but there will be smaller communities that can be permanent or short-term. This will provide more leadership opportunities in the organization.




2007 Annual Meeting: A Crowne of Jewels

In Memoriam



Dr. Joyce O. Rasdall, retired professor at Western Kentucky University and past president of KAFCS, of Smith’s Grove, Ky. passed away on October 23, 2006, following a courageous battle with cancer. In AAFCS she received the Leader Award in 1971 and the prestigious Commemorative Lecture Award

in 2005. In KAFCS she was Vice President for External Affairs and served on numerous committees. She was on the board of Phi Upsilon Omicron Educational Foundation and was active in Beta Delta Alumni Chapter at Western. She is survived by her husband, a son and daughter, and two grandchildren.

Mrs. Gladys M. Lickert, Louisville, died April 10 at the age of 93. Mrs. Lickert served as president of KHEA (now KAFCS) from 1964-65. Prior to retirement, she was a State Extension Specialist in Housing for the University of Kentucky Extension Service.

The crash of Comair Flight 5191 in Lexington on August 27 took the life of **Dr. Larry Turner**, Associate Dean for Extension in the UK College of Agriculture. Dr. Turner was a true friend of Family and Consumer Sciences who will be missed throughout the entire state. Our heartfelt sympathy goes to his family and colleagues.

What you Need to Know About Changes in AAFCS (Adapted from AAFCS *Fast FACS*, July 2006)

During the AAFCS Annual Conference in Charlotte last June, Senators voted to postpone the automatic dues increase for Active, Associate, and New Professional members for FY 06-07. The proposed resolution was amended and passed as a Resolution of AAFCS on Non-Discrimination. Senators also made decisions about the proposed Recommendations for Action to Transform AAFCS for a New Era of Action. While the complete results are posted under “What’s New” at www.aafcs.org, some highlights are:

- Mission--Amended the proposed revised statement to read: “The mission of AAFCS is to provide leadership and support to professionals whose work is to assist individuals, families, and communities in making informed decisions about their well-being, relationships, and resources to optimize their quality of life.” It will be posted on the website for a period of time for public comment and then presented for a second vote.
- Governance--Streamlines structure of Board of Directors and Finance Committee (effective immediately).
- Membership--revised the proposed Recommendations for Action, effective May 1, 2007. Active membership will be limited to: “Professionals with a degree in FCS or related field working toward or supporting the vision and mission of AAFCS.”
- Structure--approved a name change for the Preprofessional/Graduate Student Section. Effective immediately it will be known as the “Student Unit.” Effective May 1, 2007, AAFCS will be moving from Sections and Divisions to Communities of Interest/Practice.

Eastern Kentucky University Department of Family and Consumer Sciences

I am very happy to report the Department of Family and Consumer Sciences, including all B.S. programs, gained full accreditation by the American Association of Family and Consumer Sciences (AAFCS) in November 2005.

The accreditation report included six commendations: strengths of the curriculum, system of planning and assessment, the Chair, the faculty, and faculty commitment to mentoring students.

The faculty and staff of the Department worked hard and effectively in conducting the self study and preparing for the site visit. The FCS Advisory Board and many alumni also provided considerable support and hard work in advance of the self study and site visit. To each of you - Thank you very much! The students and alumni representing the Department were also a great source of pride to us.

This year it is a pleasure to introduce two new faculty members in the Department. Lynn Barnes is teaching in the Apparel Design and Merchandising program. Paul Jacobs is teaching in Child and Family Studies.

Lynn Barnes is near completion of her Ph.D. dissertation at The Ohio State University. Her research focus is the transformation of couture clothing into sportswear and ready-to-wear. Lynn's M.A. is from San Francisco State University. Her research there focused on country image and the relationship between perceived garment quality and purchase.

Lynn's vast work experience includes sourcing with Indika Textiles, merchandising with Nordstrom and Neiman Marcus and costume designing with theatres in California and Ohio. She has taught at Bluffton University and San Francisco State. Her numerous juried papers have been presented to the Costume Society of America, the Smithsonian Masters Students Symposium and the International Textile and Apparel Association

Paul Jacobs, new faculty member in early childhood, has his Ph.D. from the University of Texas--Austin in Curriculum and Instruction. He has taught at University of Texas-San Antonio and Mississippi State. Paul's research areas are children's playgrounds, playwork and social well-being. Paul has several refereed publications in early childhood. Outside the university, he has collaborated with an architectural firm on playground design, worked as a preschool teacher and directed an after-school program.

University of Kentucky School of Human Environmental Sciences

The new academic year is off to a quick start. Our enrollment of 889 is 100 more students than this time last year!

This year the School of Human Environmental Sciences will celebrate its Centennial Anniversary. You are invited to attend our celebration on March 3, 2007 in Lexington at the Crowne Plaza Hotel. Plan to stay after KAFCS to be a part of this celebration. Additional details will follow.

As you walk through the School, you will also meet new faculty and staff members: **Marianne Smith Edge** is coordinating a media feasibility study to evaluate expanding into new media venues for family and consumer sciences extension programming. **Tim Lanham** is the Program Coordinator for the Extension Investment and Financial Education Project. **Dr. Anna-Mae Kobbe** will be joining us over the next year to facilitate Charting Our Course: 2006-2007 Planning Initiative. **Dr. Cheryl Mimbs** is Assistant Professor, Family and Consumer Sciences Education, Department of Family Studies. **Bob Perry** has been hired as the Food Systems Initiative Coordinator.

As we begin the new school year, we also have changes in the School's administrative team. After seven years as Department Chair for Nutrition and Food Science, **Dr. Hazel Forsythe** has decided to return to a faculty role, revitalize her autism and nutrition research, and engage in broader teaching responsibilities. **Dr. Janet Kurzynske** assumed the role of Acting Department Chair following her role as the Food and Nutrition Specialist for FCS Extension. **Dr. Tricia Dyk** completed her assignment as Interim Department Chair for the Department of Family Studies. **Dr. Claudia Heath** will serve as Interim Department Chair effective July 1, 2006-June 30, 2007 or until the Chair's vacancy is filled. **Dr. Janet Tietyen** will serve as Interim Director of the Research Center for Families and Children. **Dr. Kim Henken** was named Assistant to the Director of the School of Human Environmental Sciences.

In other news, **Dr. Kwaku Addo** led his UK 300 cross cultural course to Ghana this June accompanied by students from Prairie View A&M. **Dr. Sean Davis** received this year's American Association for Marriage and Family Therapy Dissertation Award. Sean served as the Department of Family Studies' MFT doctoral intern during the 2004-05 year and has continued participation in the MFT program as a part time instructor. **Dr. Sunny Ham** was promoted to Associate Professor of Nutrition and Food Science. **Dr. Hyungsoo Kim** was selected to participate in the National Institute on Aging, Summer Institute on Aging Research. He was chosen as one of only 37 applicants in a highly selective process for the weeklong institute. **Dr. Susan Michelman** was accepted into the Circles of Power (COPS) Leadership Program sponsored by UK President Todd's Commission on Women. **Jessica Niblock**, a graduate student in Nutrition and Food Science, was

Western Kentucky University Department of Consumer and Family Sciences

We in the Department of Consumer and Family Sciences have much to be proud of again this year. Our programs continue to grow and we currently are the largest department in terms of majors in our college (Health & Human Services). Our students are doing exceptionally well, and have been recognized for their achievements: **Shelby Cotton** (Hospitality Management & Dietetics) was the eighth Scholar of the College since Fall 2000.

Heather Martin, Interior Design, won the national competition sponsored by Moen for a new faucet design. Her solution will be manufactured and be available for retail sale during the coming year. Heather's solution, which was adaptable for individuals with disabilities, as well as different uses for kitchen as well as bathroom, was judged to be superior to those designs created by professional practicing designers. Other Interior Design students entered the Watkins School of Design competition and two of our majors were on the winning teams for Best Overall Design, and Best Approach to a Community Living Solution. The focus was on Nashville's Magdalene House Living Community Design. **Laura VanVleet** was recognized as the Outstanding Student in a Dietetic Didactic Program in Kentucky. Many of our students have been awarded significant scholarships as well.

We added two great new faculty this year: **Ms. Julie Lee**, MBA, RD, was Executive Chef/Production Manager at Good Samaritan Hospital in Cincinnati, OH. In addition to being a Registered Dietitian and Licensed Dietitian, she is a Certified Working Pastry Chef, and a Certified Sous Chef. **Dr. Connie Jo Smith**, a long-time member of the Training/Technical Assistance Services team, has joined our faculty full-time in Child Studies and Early Childhood Education. Dr. Smith has also been selected as a member of the newly established NAEYC accreditation team for Associate Degree programs in Early Childhood Education. **Dr. Louella Fong**, Department Head, will retire at the end of the academic year effective July 1, 2007 after 37.5 years of service. Our faculty continue to be active professionally and many are officers on the boards of their professional organizations.

The department's programs are undergoing some curricular changes which are going through the university committee system now. We are streamlining programs as well as ensuring that students in each major/concentration receive as comprehensive an education as possible. Keep tuned in to our departmental web page for ongoing information. Many of our programs offer some or all of the coursework online in order to meet the needs of distance students. This effort has been very beneficial to everyone involved.

Our newest achievement has been the move of our Early Childhood Center (ECC) to the brand new Clinical Education Complex which was recently dedicated and opened. The ECC has been in operation over the past two years out of a classroom, and the newly designed space provides a wonderful training environment for our students, and a one-of-a-kind intervention and educational opportunity for the children and families served. In addition to the Early Childhood Center, the Clinical Education Complex houses the Kelly Autism Program, the Communication Disorders Clinic, the Acquired Brain Injury Program and the Family Counseling Center. We believe that not only is this the only

Celebrating Success

Outstanding members were honored for their accomplishments and contributions to the profession during the annual Awards Luncheon at the 2006 KAFCS Annual Meeting in Louisville. Photos appear on kafcs.com.

Marisa FitzGerald, Jessamine County Extension Agent for Family and Consumer Sciences, was the 2006 New Achiever Award recipient. Marisa is dedicated to her professional organizations, serving as the Vice President of Programs for KAFCS and chair of the state meeting program. In her community, as chair of the Women's Wellness Forum, Marisa partners with community groups to improve the lives of women in Jessamine County. Marisa's concerns are far reaching. During the past year, many people in the world community were devastated by natural disasters. Marisa raised funds for the Tsunami Relief Fund and participated in a relief team during Hurricane Katrina.

The 2006 recipient of the Teacher of the Year Award is **Marilyn Bailey**, who has a cutting edge FCS program in Barren County. The program is based on career majors and aligned to the national

standards with scoring and analysis for Kentucky Occupational Skill Standards. Barren County High School students with career majors consistently score higher on state accountability exams. Marilyn and her co-workers advise an active Family, Career, and Community Leaders of America chapter. Students are inspired to leadership positions at the chapter, region and state levels.

The 2006 Wiley Berger Award honors a 40-year veteran professor of textiles and clothing at Western Kentucky University. **Dr. Martha Jenkins** has been a leader in our profession as national president of Phi Upsilon Omicron, officer of the Costume Society of America - Southeast region and numerous committees at WKU.

Dr. Jenkins applies her professional experiences and dedication to community volunteerism. Last year's natural disasters inspired Dr. Jenkins to assist with Katrina relief collections.

Recently, Dr. Jenkins collected used cell phones which were reworked and given a preset amount of minutes. The reworked phones are given to abused women to use in emergency situations. Dr. Jenkins is an inspiration to all FCS professionals to apply their knowledge and skills to benefit the less fortunate.

Presenter(s) name(s) (names will be removed from copies sent to jurors), current position, institution/organization, mailing address, telephone numbers and e-mail address for each presenter.


Type of Presentation

- The non-discrimination statement was modified somewhat and is more inclusive of diverse populations.

These changes will begin to take place in May 1, 2007, with the exception of the Student Unit name change, which was immediate.
